

PARTNERSHIP ECLECTIC CHAIR

JOB DESCRIPTION

GENERAL

1. All members of the Board of Directors and Committee Chairs should be familiar with the By-Laws and Standard Operating Procedures for our club, as these are the sources of authority and guidelines for conducting association business. The references cited below are particularly pertinent to this position.
2. This game is the best score of two partners made on each hole on assigned Eclectic playdays. Each partner will have an individual score card and the Partnership EC Tournament Chair will log the best score for each partnership on each hole.

DUTIES:

1. The Partnership Eclectic Chair shall be in charge of the Partnership Eclectic Tournament.
2. The Partnership Eclectic Chair and the Thursday Play Day Director will determine dates (as many as possible) when Rounds may be played, and bring score cards to the sign-in tables on those dates.
3. The Chair will inform all players in advance, when rounds may be played. Rules and dates will be posted in the Posting Room.
4. The Partnership Eclectic Chair will arrange to have special score cards printed for the players. The cards should be created on "Hard Stock" paper. (Cost to be charged to the club: Administrative.)
5. The Partnership Eclectic Chair will create a sign-up sheet and collect a fee (currently \$5) from each player to cover awards. Money collected should be turned over to the Treasurer until the Tournament is finished.
6. The Partnership Eclectic Chair will create a spreadsheet with names of all team players and keep track of scores.
7. A spreadsheet showing flights and current team scores shall be posted in July.

RULES:

1. Any member of "The Association", who is in good standing, will be eligible to join the tournament at anytime. Rounds shall be played on days when all members are eligible to play.
2. Sign-up will start first play-day in February and will run through the month of May.
3. The Eclectic Partnership Tournament will consist of 8 rounds for each partner, played on designated dates as posted in the Posting Room.
4. The tournament starts the first paly day in March and will terminate at the end of October.
5. The July 1 revision will be used for handicapping purposes.
6. Allowed configurations for Partnership EC: 1.) Both Players from the 3/2 Combo Tee's, 2.) One Player from the #2 Tee and one Player from the 3/2 Combo Tee, 3.) Both Players from the #2 Tee's.
7. Team handicaps are created by the total of both handicaps divided by two. If there are more than 8 strokes between partner's handicaps, the team handicap will be adjusted by lowering the higher handicap.
8. Divide Teams into even Flights, four if possible. Flights will remain the same throughout the Tournament. Flight recommendations are as follows:
 - Mixed Tee Partners, one partner 3/2 Combo Tee's with one partner #2 Tee's
 - Both Partners from #2 Tee's
 - Both Partners from the 2/3 Combo Tee's
9. July 1 handicaps will also be used to determine the final results.

PLAY:

1. On all designated days, the EC box will be placed near the sign-in table. Score cards will be in alphabetical order.
2. Once the EC scorecard has been picked up by the Player, it will be recorded as a Round played, whether or not any scores on any holes have been improved.
3. Score cards must be picked up before the player starts the first Round.
4. The Player will record the Gross score on the EC Card for all 18 Holes for the first round.

5. From that point on, only scores on holes that have been improved, shall be recorded.
6. The EC scorecard must always be attested by a player in the group, other than the partner.
7. On the days when EC Rounds are being played, the players should not pick up on any hole if they wish that score to be used.
8. Immediately after play, the EC scorecards shall be returned to the EC Box, which will be placed in the Posting Room. Failure to do so may result in disqualification.

RESULTS & AWARDS:

1. Final results for the Partnership Eclectic Tournament will be announced at the November General Meeting. Cash awards will be distributed at that time.
2. Fees collected, \$5 per player, shall be used for awards.
3. Final flights and handicaps used, will be as per July 1 revision.
4. Ties will be broken using the USGA recommended method.
5. The Chair may decide, if there shall be an over-all team winner in addition to flight winners.
6. Final results will be posted in the posting room.

END OF TERM DUTIES:

1. The Partnership Eclectic Chair will update the current Job Description, as appropriate, and submit a copy to the Policies and Procedures Administrator and the Captain.
2. The Partnership Eclectic Chair will write a report for the term and submit a copy to the Captain and the new Chair.
