

PARTNERSHIP ECLECTIC CHAIR JOB DESCRIPTION

GENERAL

1. All members of the Board of Directors and Committee Chairpersons should be familiar with the By-Laws and Standard Operating Procedures (SOP's) for our club, as these are the sources of authority and guidelines for conducting association business. The references cited below are particularly pertinent to this position.
2. This game is the best score of two partners made on each hole on assigned Eclectic playdays. Each partner will have an individual score card and the Partnership EC Tournament Chair will log the best score for each partnership on each hole.

DUTIES:

1. The Partnership Eclectic Chairperson shall oversee the Partnership Eclectic Tournament.
2. The Partnership Eclectic Chairperson and the Thursday Play-day Director will determine dates (at least 14-15) when rounds may be played. She will bring score cards to the sign-in tables on those dates.
3. The Chairperson shall take personal possession of the EC scorecards that are not retrieved for use during and between play dates. EC cards are not to be stored in the Posting Room.
4. The Chairperson will inform all players in advance, when rounds may be played. Rules and dates will be posted in the Posting Room and may be distributed to the membership by the Captain via "blast", as appropriate.
5. The Partnership Eclectic Chairperson will arrange to have special score cards printed for the players. The cards should be created on "Hard Card Stock" for durability. Cost to be charged to the club.
6. The Partnership Eclectic Chairperson will create a sign-in sheet and collect a fee (currently \$10 per team) to cover awards. Money collected should be turned over to the Treasurer until the Tournament is finished.

7. The Partnership Eclectic Chairperson will create a spreadsheet with names of all players and keep track of scores.
 - a. The spreadsheet showing flights and current team scores shall be posted in July.

RULES.

1. Any member of "The Association", who is in good standing, will be eligible to join the tournament anytime. Rounds shall be played on days when all members are eligible to play.
2. Sign-ups will start the first play -day in February and will continue through the month of May.
3. The Eclectic Partnership Tournament will consist of eight rounds for each partner, played on designated dates as posted in the Posting Room.
4. The tournament starts on the first play day in April and will terminate at the end of November.
5. The July 1 revision will be used for team handicapping purposes.
6. Allowed configurations for Partnership Eclectic: 1) both players play from the 3/2 combo tees, 2) one player plays from the 3/2 combo tees and one player plays from the 2 tees, 3) both players play from the 2 tees.
7. Team handicaps are created by the total of both handicaps divided by two.
 - a. If there are more than 8 strokes between partner's July 1 handicaps, the team handicap will be adjusted by lowering the higher handicap.
8. Three to four flights are recommended.
 - a. Flights should be divided as evenly as possible.
 - b. It is recommended that the flights be assigned along natural breaks in the team handicap roster, allowing the handicap system to work to achieve parity between teams.
 - c. It is not recommended that flights be artificially re-sorted according to tee designations.

9. July 1 handicaps will also be used to determine the end results.
10. Payouts will be 1/3 of the field of each flight.

PLAY:

1. On all designated play days, the EC box will be placed near the sign-in table. Score cards will be in alphabetical order.
2. Once the EC scorecard has been picked up by the player, it will be recorded as a Round played, whether any scores on any holes have been improved or not, regardless of if the player later withdraws.
3. Score cards must be picked up before the player starts the Round and before 8:15am.
4. The first time a Round is being played, the gross score shall be recorded on the EC scorecard for all 18 holes. From that point on, only scores on holes that have been improved, shall be recorded.
5. The EC scorecard must always be attested by a player in the group, other than the EC partner.
6. On the days when EC Rounds are being played, the players should not pick up on any hole if they wish that score to be used.
7. Immediately after play, the EC scorecards shall be returned to the EC box, which will remain in the possession of the Eclectic Chairperson.
 - a. Failure to return the EC score card to the box may result in disqualification for that day.

RESULTS AND AWARDS:

1. Final results for the Partnership Eclectic Tournament will be announced at the Holiday Luncheon in early December. Cash Awards will be distributed at that time.
2. Fees collected, \$10 per team, shall be used for awards.
3. Final flights and handicaps used shall be as per July 1 revision.

4. Ties will be broken using the USGA recommended method.
5. The Chairperson may decide if there shall be an overall team winner in addition to flight winners.
6. Final results shall be posted in the Posting Room.

END OF TERM DUTIES:

1. The Partnership Eclectic Chairperson shall update the current Job Description, as appropriate, and submit a copy to the Policies and Procedures Administrator.
2. The Partnership Eclectic Chairperson shall write a report summarizing the action during the term and submit a copy to the Captain and the new Chairperson.
